### **Message From The Chair**



Dear Business Law Section Members:

I am writing on behalf of your Section's leadership. It gives me great pleasure to tell you what we have accomplished so far this 2016-2017 Bar Year as section leaders.

First and foremost, to communicate on a timely basis the Section's accomplishments, we have improved our website tremendously. You can find it at http://texasbusinesslaw.org/. Log in by using your bar number as a username and the password you personally set. There, you will find a wealth of resources, including presentation papers and slide sets from past CLE courses the Section has sponsored, as well as past newsletters, and other practice aids.

Specifically, under the heading "Research Resources," you can find the latest issue of the Texas Journal of Business Law, including articles on defeating class certification, the Texas margin tax, and shareholder oppression. Past Journal issues are being digitized and will be posted as soon as they are ready. That will allow you to recycle your paper copies, should you so desire.

Through March 24, 2017, over 8,300 pieces of legislation, including resolutions, have been filed at the Texas Legislature during this session. How do you know which are important to your business law practice? Under the "Research Resources" heading in the website, you will find your Section's Texas Legislative Update in the form of a report. In the Legislative Update, your Section tracks bills pertinent to ten business law subject-matter categories, including: Business Entities, Securities, Financial Institutions, Real Estate, Taxation, and Choice of Law. Also included are bills that the leadership of your Section prepared, such as amendments to the Texas Business Organizations Code related to Corporations, Non-Profits, Partnerships, and LLCs, as well as amendments to the Texas Uniform Trade Secrets Act. A new Update report will be posted weekly during the Legislative session, so be sure to check the Section's website every Friday.

Other materials found on the website are various non-profit business entity forms and documents, such as example by-laws, and a Policy on Conflicts of Interest and Disclosure of Certain Interests.

Your Section's leaders, who make all this happen, are identified under the "Committees" heading. I thank them and congratulate them for what they have accomplished this 2016-2017 Bar Year. You will find several committees need vice chairs. I invite you to contact the Chair of the committee in which you may have an interest to become involved, or contact me directly. I have been a member of your Section's leadership for over two decades. Like me, I am sure you will find your involvement rewarding, educational, and helpful to your business law practice!

### Highlights of the Texas Journal of Business Law: Vol. 47 No. 1

Issue 47:1 features articles on *Halliburton II*, Texas's margin tax, and shareholder oppression. Mr. Roger B. Greenberg & Mr. Zach Wolfe attended an oral argument hearing in the Fifth Circuit in August 2016 regarding Halliburton and class certification. Mr. Greenberg and Mr. Wolfe have previously written articles for the Journal following the case history and development of Halliburton. Their most recent article, *Halliburton II*, focuses on an narrow appeal regarding whether defendants may prove a lack of "correctiveness" to defeat class certification. Though the parties have settled out of court prior to the Fifth Circuit rendering a formal opinion, their analysis is very fruitful for future federal securities fraud cases involving sufficiency of pleadings at the class certification stage. Ms. Nikki L. Laing analyzes the Texas's franchise or "margin" tax, specifically its expansion to entities never-before subject to the tax and alteration of how the tax is now calculated. Ms. Laing's article reviews constitutional challenges to the margin tax in the Texas Supreme Court, varying commentary on the margin tax's categorization as an income tax, and applicability of "costs of goods sold" deductions. In part one of this two-part article, Mr. Eric Fryar reexamines the history of shareholder oppression in Texas and how the court's ruling in *Ritchie v. Rupe* has affected protection afforded to minority shareholders against oppressive conduct by controlling shareholders. Part two of Mr. Fryar's article will be included in Issue 47:2.

In addition, this issue includes recent business developments summarizing cases involving: (1) whether arbitration clauses in engagement letters are binding when the client doesn't sign and the party suing is doing so derivatively; (2) whether UCC Article 4 in Texas preempts common law fraud and breach of contract claims in the relationship between a bank and its customer; (3) whether an agreement to arbitrate disputes is illusory and thus unenforceable when one party has the power to terminate its obligation at any time, effective immediately without advance notice of termination; and (4) whether a court should mandate arbitration pursuant to an agreement when the movant challenges the formation of that contract.

Evan Young is the Business Law Section's 2017-18 Chair Elect. Evan Young is a partner with Baker Botts L.L.P., focusing his practice on trial and appellate litigation. He comes from an impressive background as a law clerk to U.S. Supreme Court Justice Antonin Scalia and Judge J. Harvie Wilkinson III of the United States Court of Appeals for the Fourth Circuit.

Evan's experience includes being Counsel to the Attorney General at the U.S. Department of Justice under Attorneys General Alberto R. Gonzales and Michael B. Mukasey. Although most of his time while serving in this role was spent at Main Justice in Washington, he also served for most of a year in the U.S. Embassy in Baghdad, Iraq, where he was the Deputy Rule of Law Coordinator. In that position, he worked with the Iraqi government to strengthen Iraq's legal infrastructure, primarily focusing on Iraq's courts and prison system.

After his time at the Department of Justice, Evan and his wife Tobi returned to Texas. Evan joined the Austin office of Baker Botts in 2009.

Until this year, Evan has been the Chair of the Business Law Section's Judicial CLE Committee. (He recently ceded this position to the current Chair of this committee, James P. Sullivan, a Senior Associate at King & Spalding). In July 2015, the Texas Supreme Court issued an order signed by all its justices appointing Evan to the Supreme Court Advisory Committee, a group of judges, practitioners, and professors who are asked to study the various rules of the Texas courts and make recommendations to the Supreme Court to improve them.

Recently, Evan received an additional testament to his excellence as an attorney. He was appointed by Governor Abbott to become one of six citizen members of the Texas Judicial Council (TJC). Chaired by Chief Justice Nathan Hecht, the TJC is the policy-making body for the State's judiciary. The Legislature created it in 1929 to continuously study and report on the organization and practices of the Texas Judicial Branch.

According to its website at, <a href="http://www.txcourts.gov/tjc.aspx">http://www.txcourts.gov/tjc.aspx</a>, the TJC "studies methods to simplify judicial procedures, expedite court business, and better administer justice. It examines the work accomplished by the courts and submits recommendations for improvement of the system to the Legislature, the Governor and the Supreme Court."
